



MEMORANDUM OF UNDERSTANDING BETWEEN

GENERAL ELECTION COMMISSION OF REPUBLIC OF INDONESIA (KPU) AND

ASIAN NETWORK FOR FREE ELECTIONS (ANFREL) ON COOPERATION FOR CAPACITY BUILDING ON ELECTION

Tuesday, The Eighth of March two thousand and sixteen, in Jakarta, the following signatories:

- I. HUSNI KAMIL MANIK, as Chairman of General Election Commission of Republic of Indonesia, acting for and on behalf of the General Election Commission (KPU), stationed in Jalan Imam Bonjol Number 29, Central Jakarta 10310, hereinafter referred to as FIRST PARTY.
- II. DAMASO G. MAGBUAL, as Chairperson of Asian Network for Free Elections (ANFREL), having position in 105 Suthisarnwinnichai Rd, Huaykwang Bangkok – Thailand 10310, in this instance acting for and on behalf of ANFREL, hereinafter shall be referred to as SECOND PARTIES.

The FIRST PARTY and the SECOND PARTY, collectively referred to as PARTIES, agree to cooperate as arranged in this Memorandum of Understanding under the following provisions:

OBJECTIVE

Article 1

The objective of this Memorandum of Understanding is to cooperate to support the electoral process in Indonesia by exchanging knowledge and expertise.

SCOPE OF WORK

ARTICLE 2

The scope of this Memorandum of Understanding is cooperation in capacity building in the matter of election, includes:

- (1) Support from the SECOND PARTY based on the needs of the FIRST PARTY to conduct programs and cooperation activities as collectively agreed while still ensuring the independence of the FIRST PARTY;
- (2) Support for the FIRST PARTY as referred to in paragraph (1) is conducted through focus group discussions (FGD), research, workshop and education, international conference, resources, as well as other forms of support;
- (3) Technical electoral support is not related to the conduct of election stages;
- (4) Other activities mutually agreed upon by the PARTIES.

CONDUCT

Article 3

The implementation of this Memorandum of Understanding, will be stipulated in an Agreements created and mutually agreed upon by the PARTIES.

FUNDING

Article 4

- (1) This Memorandum of Understanding does not imposes any financial commitment to the PARTIES;
- (2) Costs incurred from the implementation of this Memorandum of Understanding are charged to each PARTY as governed by the law.

TIME PERIOD

Article 5

- (1) This Memorandum of Understanding is in effect for 2 (two) years after being signed by both PARTIES and it can be extended by the agreement of the PARTIES;
- (2) Should one party wish to cancel this Memorandum of Understanding, that party shall notify the other party of their intent on written notification.

CONSENSUS

Article 6

All disputes or disagreements that arise from the implementation of this Memorandum of Understanding shall be settled through a discussion to reach a consensus by the PARTIES.

CONCLUSION

Article 7

This memorandum of Understanding is made in both Bahasa Indonesia and English. These two documents are signed by BOTH PARTIES, and both have the same legal authority. And each copy of this MoU will be given to each party.
